- ❑ For General Dentists and Specialists (except Orthodontists and Oral Surgeons).
- ❑ “Claims-Made” policies with “Prior Acts” protection.
- ❑ Limits of liability from \$100,000/\$300,000 up to \$3,000,000/\$3,000,000.
- ❑ Defense costs do not reduce limits of liability. They are paid in addition to those limits.
- ❑ Zero deductible for qualified Dentists.
- ❑ NCC will not settle a professional liability claim without the Dentist’s consent.
- ❑ The Dentist will be defended by attorneys who specialize in handling dental liability claims.
- ❑ Policy can be issued to an individual Dentist or can insure all Dentists in an office under one policy with each Dentist having his or her own individual limits and separate retroactive dates for prior acts coverage. Optional separate limit of liability available for the Entity for a modest additional charge. Groups of 4 or more Dentists under one policy can obtain a sizable premium discount.
- ❑ The policy will reimburse the Dentist up to \$500 per day if his or her practice is interrupted to assist NCC in the defense of a claim or suit.
- ❑ Locum Tenens coverage.
- ❑ Innocent Persons Protection.
- ❑ The policy will pay up to \$500 per dental incident if the Dentist accidentally damages patient property.
- ❑ First Aid coverage with a \$5,000 each person limit is included at no additional charge.
- ❑ Contractual liability coverage included for dental incidents arising from the Dentist’s contracts with HMOs, PPOs, IPAs or similar health maintenance organizations.
- ❑ Free unlimited reporting endorsement (tail coverage) upon retirement for Dentists aged 55 or older and insured by NCC for a minimum of 4 years prior to retirement. Free unlimited tail coverage in the event of death or permanent and total disability. Otherwise, unlimited tail coverage available at fixed cost of 200% of the last annual premium.
